## DUE DATES AND OTHER REQUIREMENTS FOR GRANTS, ETC.

- Prompt payment rules any word if these might get suspended? Any chance Infrastructure Ontario might be looking at providing temporary operating loans?
  - As far as we are aware, nothing confirmed by the Province to date. Lawyers, however, have weighed in. Refer to <u>Denton's</u> summary.
- Temporary Operating loans from Infrastructure Ontario:
  - Nothing seen to date.
- Will the Service Delivery Review deadlines be extended by MMAH beyond Sept 18? We just signed Transfer Payment Agreement agreeing to that but won't be able to meet it. Our RFP just closed March 12 and have not met to award as we do not wish to proceed at this time since cannot properly complete the review without the consultants being onsite and conducting some face to face interviews.

- Will requirements to complete the Financial Plan for Water Licencing be extended? We were just about to start that work for completion later in the year and due to heavy workload COVID has placed on us and inability to meet with consultants, that may be delayed.

- Will the various grant reporting be extended? Eg. AMO gas tax (addressed in yesterday's Provincial Economic update), OCIF, source water protection. Due to the heavy workload COVID has placed on us, we've been unable to get to the regular day to day work.

- Also payments of EHT, WSIB, OMERS, HST collected will payment dates be extended → MFOA
  WSIB payments extended to August 31, EHT also extended (not 100% clear if municipalities are included as Schedule 2 group) fiscal update last night

  - OMERS no word yet

- Hard to wrap thoughts around what to propose for 2021 budget at this time. yesterday's fiscal update reduced OMPF - MFOA - clarify it was not a reduction in OMPF, announced at ROMA and in October 2019 that OMPF would be \$500M, last night reported at \$501.9M

- Are municipalities able to take advantage of the 10% offer by the Feds
  - From the Department of Finance's <u>webpage</u>: "To support businesses that are facing revenue losses and to help prevent lay-offs, the government is proposing to provide eligible small employers a temporary wage subsidy for a period of three months. The subsidy will be equal to 10% of remuneration paid during that period, up to a maximum subsidy of \$1,375 per employee and \$25,000 per employer. Businesses will be able to benefit immediately from this support by reducing their remittances of income tax withheld on their employees' remuneration. Employers benefiting from this measure will include corporations eligible for the small business deduction, as well as non-profit organizations and charities."

Should we be coding everything re:covid19 to different accounts?

- We have created a new code to track all COVID-19 expenses. Right now, loss of revenue is much more important and impactful than the additional expenses we have incurred thus far
- We are tracking extraordinary only in separate accounts. Everything else will be a budget variance in the respective areas.
- We have also created a separate code to track COVID 19 costs and revenues are the largest concern for us also.
- Expectation is that if Province provides assistance it will not be on a claim basis but rather an allocation basis.
  - It is recommended to keep track of expenses. Some municipalities are using the frameworks they developed during previous natural disasters to take advantage of available funding.

Is MFOA going to advocate for the Ministry to defer (indefinitely) the Development Charges Act and Planning Act changes as they relate to growth and community service benefits?

- MFOA is in communication with MMAH about changes to the Development Charges Act and the Planning Act.

- I was wondering if there has been any decision by the Province to delay the due date for the first quarterly payment (currently scheduled for March 31<sup>st</sup>) to the school boards?
  - None that we are aware of.
- Is MPAC going to look at the valuation date of Jan 1, 2019 which will now be 2 years beyond the taxation year and will be 6 years out of date by the time the four-year cycle is completed. This could have significant implications for municipal tax rate setting on values that are not reflective of market values
- **MFOA** re: Reassessment I believe that there no definite plans at this point in time and the Province is still evaluating next steps.
- I reached out to my Account Manager at MPAC last night, and that was one of my questions too. He had no further details at the moment, but said we'd be informed when they do know.

- I am getting questions from commercial landlords about extending the vacancy rebate program to cover businesses forced to close due to Covid-19. Any talk about this?
- Check out S.357 and 365 for residential- 365 is more flexible according to MTE- having been involved at the drafting stage I would agree; on vacancy rebate check regulation wording under Assessment Act
- Midland to deal with tax due date deferral next week. Agenda report will be live this afternoon.
- Ford government announced "\$1.8 billion to pay for the 3 month deferral of property tax payments municipalities are required to make to school board for 3 months" "Municipalities urged, but not required, to provide deferrals to municipal taxpayers". Can you provide further clarification of this statement? is this \$1.8 directly for the education tax levy? or are we going to see subsidy from the government to offer a deferral program?
  - Our understanding is that the \$1.8 billion is to ensure the education deferral does not have a financial impact on school boards. The Province is adjusting payments to school boards to offset the deferral.
- as ex MOF the levy subsidy will go directly to the boards just gives you room for deferrals

## PURCHASING AND PROJECTS UNDERWAY

Are municipalities continuing with construction tenders or delaying for 2020 to help with cash flows, etc?

- We are working on procurement language to cover the possibility of canceling projects, addressing revised contractor H&S around Covid issues but are currently planning on going out to quote on projects
- construction was identified as essential service, so we are continuing with tenders that we would issue at this time of the year for grass cutting, line painting, etc
- Are municipalities continuing with the Service Delivery Review funded by the Mun Modernization funding announced recently?
